

Please refer this office letter no. 60/SE(QA/QC)/PTCUL dated 19.01.2019 and 71/SE(QA/QC)/PTCUL dated 21.01.2019 vide which MQP of 220 KV C&R Panel & SAS for Construction of 220 KV GIS at Baram Jauljivi, Pithoragarh as a sub-vendor of M/s Capital Electech Pvt. Ltd. and 132 KV & 33 KV C&R Panel for Construction of 132/33 KV Padartha, Haridwar as a sub-vendor of M/s SNS Technocorp Pvt. Ltd. was approved.
